## **COMPLAINT**

**COMES NOW**, Florida Society of Addiction Medicine, Plaintiff herein, hereby files this Complaint against John Harden, Defendant herein, and alleges:

## PARTIES

1. Plaintiff, Florida Society of Addiction Medicine, Inc., has a principal place of business in Alachua County, Florida.

2. Defendant, John Harden, an individual, resides at 420 South Oregon Avenue, Tampa in Hillsborough County, Florida.

### JURISDICTIONAL STATEMENT

3. The amount in controversy exceeds \$15,000.00, excluding interest, costs and attorney's fees, which is within the jurisdiction of the court in accordance with Section 26.012 of the Florida Statutes.

### VENUE

4. Venue in Hillsborough County, Florida is proper in this action under Section 47.011 of the Florida Statutes because the defendant resides in Hillsborough County.

### COUNT 1 Conversion

5. Defendant was the Executive Director for Plaintiff's business, Florida Society of Addiction Medicine.

6. On or about October of 2016, Plaintiff discovered that Defendant had wrongfully took into his possession funds from the company's accounts.

7. As of November 8, 2016, there was a balance of \$335,127.31 that had been taken by Defendant from Plaintiff. (Please see Exhibit "A")

8. On or about that date, Plaintiff discovered that Defendant had knowingly obtained and used \$335,127.31 which belonged to Plaintiff with the intent to, either temporarily or permanently, deprive Plaintiff of the right to the money and to appropriate the money to Defendant's own use in violation of Section 772.11 of the Florida Statutes.

9. As a result, Plaintiff has been injured because of the violation of Section 772.11 of the Florida Statutes and has lost the above sum plus interest from the date of the theft.

10. Before filing this suit, Plaintiff on December 30, 2016 served on Defendant a written demand for payment.

11. Defendant has failed and refused to pay the amount demanded or any other amount.

12. Plaintiff, Florida Society of Addiction Medicine, adopts by reference, as if set out fully and completely in this Count, the following statements of this Complaint: Paragraphs 1 through 13.

13. Defendant, former Executive Director for Plaintiff, wrongfully converted \$335,127.31 from Plaintiff.

14. Defendant had knowingly obtained and used \$335,127.31 which belonged to Plaintiff with the intent to, either temporarily or permanently, deprive Plaintiff of the right to the money and to appropriate the money to Defendant's own use.

15. As a result, Plaintiff has been injured.

#### **DEMAND FOR JURY TRIAL**

16. Plaintiff demands a trial of this action by jury.

#### **DEMAND FOR JUDGMENT**

WHEREFORE, Plaintiff demands a jury trial of this action, and further demands judgment against Defendant for general damages, for damages in the amount of three times the amount of the theft, and for such other and further relief, in law or in equity, to which Plaintiff may be justly entitled.
